

# FAITH BAPTIST SCHOOLS

Application for Financial Aid

Deadlines: June 1 – 1st Semester, December 1 – 2nd Semester

Financial aid at Faith Baptist Schools is based on financial need with considerations of merit related to school involvement and Christian character. The school also seeks to help families who may be experiencing “emergency” type circumstances on a short term basis, and to provide partial assistance to qualified students who could not otherwise attend. Financial aid is available for up to one-half reduction in tuition, depending on financial qualifications of applicants, classroom size, and available school funds. The following factors are considered in determining those who are eligible to receive assistance and the amount awarded:

1. Financial disclosures
2. Christian testimony and witness
3. School involvement and participation
4. Disciplinary record, if any
5. Number of years attending Faith Baptist
6. Number of children enrolled at Faith Baptist
7. Payment history (bad checks; overdue payments; etc.)
